I. GENERAL INFORMATION

1. ASSESSING YOUR VIETNAM DRIVING LICENSE CASES

When evaluating your situation, it is essential to determine which case applies to you. Here are three frequent circumstances to consider:

➔ CASE 1: FOREIGN DRIVING LICENSE CONVERSION:

If you have a valid driver's license from another country and wish to convert it to a Vietnam license, you only have to show up at the government office for about 45 minutes to finish the paperwork with all of the prepared documents.

➔ CASE 2: THE ADDITIONAL (A1) MOTORBIKE CATEGORY

If you have a foreign car driving license and desire to acquire a Vietnam motorbike license, you must undergo a motorbike driving test to meet the requirements.

➔ CASE 3: A NEW APPLICANT FOR THE DRIVING LICENSE (A1/A2)

If you are a first-time applicant for a Vietnam driver's license, you must adhere to the application procedure specified by the local traffic department. This includes meeting the age requirements, passing the theoretical and practical examination, and submitting the required paperwork.

The theoretical examination is 100% in Vietnamese and contains from 200 to 450 multiple-choice questions to study.

At [SaigonBikes](#), we will provide a designated course (including materials) for expats to study and take mock tests every week. The course contains 6 study sessions (A1 license) and 9 study sessions (A2 license) which are organized online/offline three (3) times per week.

*NOTE: This case requires **NONE** of the foreign driving licenses, and the Vietnamese driving license will be **A LIFETIME DRIVING LICENSE** regardless of the length of your current Visa/Temporary Resident Card (TRC) status.*

➔ CASE 4: VIETNAM DRIVING LICENSE RENEWAL (A1/A2/B1)

If your Vietnam driver's license is about to expire, you will be required to renew it before driving. Check the foreign license's validity period and initiate the renewal procedure prior to its expiration.

2. VIETNAM DRIVING LICENSE INFORMATION

The expiration date of a Vietnam driving license for expats will depend on the length of their Temporary Residence Card (TRC) or Visa in Vietnam.

NOTE: The 5-year Visa exemption is a particular case, it is recommended that you check with [SaigonBikes](#) staff for the most up-to-date information on the expiration dates of Vietnam driving licenses for expats.

The Vietnam Driving Licenses are classified into several categories based on the type of vehicle that a person is qualified to operate. The categories of Vietnam driving licenses for expats may include:

A1: This category is for motorbikes with a cylinder capacity of **not more than 175 cm3**.

A2: This category is for motorbikes with a cylinder capacity of **more than 175 cm3, including the A1 category**.

B1: This category is for cars, vans, and other vehicles with a maximum seating capacity of not more than 9 people (including the driver).

Requirements:

- A valid driving license from another country but Vietnam
- A valid Vietnam Visa/TRC

CASE 2: THE ADDITIONAL (A1) MOTORBIKE CATEGORY

Requirements:

- A valid Car driving license either from another country or issued by the Vietnam government
- A valid Vietnam Visa/TRC

Service included:

- A general health check for the Driving License applicant at an appointed hospital
- A practical session at the driving school
- All of the fees for the official procedure

Total fee: For A1 Driving License 4,200,000 VND

CASE 3: A NEW APPLICANT FOR THE DRIVING LICENSE (A1/A2)

Requirements:

- A valid Vietnam Visa/TRC

Service included:

- A designated study course for the theoretical examination.
- A general health check for Driving License applicants
- A practical session at the driving school
- All of the fees for the official procedure
- **A LIFETIME VIETNAM DRIVING LICENSE**

Total fee:

- **For A1 Driving License: 7,000,000 VND**
- **For A2 Driving License: 11,000,000 VND**

❖ Terms and Payment ❖

➔ Payment Terms:
